# **CONCEPT AGREEMENT ON PROSTHESES PROJECT UKRAINE**

- Herewith the following parties have decided to cooperate in the field of training on the job in the Netherlands for physiotherapist and ergotherapist working with people with amputations and prostheses.
- They have also decided to enable persons with amputations as a result of the war with Russia to receive prostheses in the Netherlands during this program.

### Party A:

Superhumans UA, represented by Olga Rudneva, CEO, and Andrii Vilensky, medical director.

## Party B:

Friends of Lviv represented by Peter de Vreede, chairman of the Foundation, coordinator of the project: Prostheses for Ukraine in the Netherlands, and a second board member.

#### The trainees

- 1. Superhumans will select 4 persons of their medical or para-medical staff for a 6 week training in the Netherlands. FoL will receive documentation on the participants in advance according to the conditions to be set. After positive feedback from FoL, time for travel will be fixed.
- 2. This process will be repeated every 2-3 months initially for a period of two years. During the program, evaluation will be made regarding possible continuation. Each group of trainees could additionally include 2 persons with an amputation of leg(s) to be treated in the same setting for prostheses. They travel back together to Lviv, and rehabilitation could be continued in the Superhumans clinic.
- 3. Superhumans will pay for each person participating in the training program a fixed contribution in overhead costs of € 500 to FoL in advance of the starting date of the training. All persons need to have a Ukrainian passport, documents to prove their vocational background, a letter of commitment to the project and a letter confirming their return to Ukraine after completion of the training. The accommodation (city of Delft) is free of costs and traineeship is free of charge (Basalt Revalidatie).
- 4. All trainees should have basic level Cambridge to follow successfully the traineeship. Because of joint hosting and presence of trainees from Superhumans of victims treated for prostheses, it will not be necessary but basic English is helpful in the revalidation process.
- 5. Persons to come have to be tested in Ukraine on MRSA and vaccinated against Covid-19, certificates included in the documentation and necessary for working in Dutch medical centres as well as copies of passports and medical or semi medical degree.
- 6. As additional support for most positive outcome FoL will consult Dr. Victoria Shtanko as expert in the project having the knowledge and capacity to be an intermediary between the participants and the parties involved in the project as well as a medical doctor and as Ukrainian native. She could be helpful in setting up a protocol for treatment in cooperation with medical specialists in Netherlands to be used in Ukraine.
- 7. In addendum we will add some specifications separately.

## The amputation patients in parallel activity

- 8. FoL will provide transport with wheelchair car for the persons with amputation. The costs for them will be charged to Superhumans against fixed amount in advance. One or two trainees could be in the same trip for medical support. The patients should have all legal documents and medical declaration of vaccination against RSA and a report of their general physical condition.
- 9. FoL will cover the hosting during treatment in Delft, they will also take care of registration, health insurance and guidance. Furthermore, the provision of prostheses (health insurance and Westland Orthopedie) will be set and a small daily compensation for living.
- 10. Superhumans will contribute with a fixed amount of € 500 per person for overhead expenses during the period of treatment, generally covering costs of special transport to training facility or medical therapy.
- 11. If x-ray or other scanned material and lab's test are available, Superhumans will provide this documentation to the patient to share with the medical specialist in the Netherlands responsible for the anamnesis and treatment plan.
- 12. In the initial phase of the program focus will be on amputations of 1 or 2 legs under the knee (transtibial) or 1 leg amputation on the upper leg (transfemoral) in line with the training of therapy and treatment protocol.
- 13. The continuation of the therapy program with the patients is necessary for successful treatment. The basis will be the mutual experience in the Netherlands and guarantee of prolongation of the treatment protocol in the Superhumans clinic in Lviv.
